#### PRESIDENT'S REVIEW OF CHAMBER ACTIVITIES FOR 2014

Interim President T. Hope provided an overview of the past year. He noted it was a year of change for the Chamber Board of Directors, but many things were accomplished. The completed Strategic Plan of the Chamber of Commerce was distributed to the membership in 2014 and will be reviewed annually to ensure the initiatives and events are on track.

The annual events, including Christmas in the Mountains, the Business Christmas Party, and the Lifestyle and Outdoor Adventure Trade Show have established an impressive following with local and regional business participation. This year, we added the Crowsnest Pass Visitor Guide which was instantly popular locally and regionally. 10,000 copies were distributed, with very positive feedback and will also be generated on an annual basis, building it going forward. The Chamber continues to administer the contract for the Visitor Information Centre near the BC border. There were nine Chamber Luncheons and two Chamber Breakfasts in the past year. Overall a good year for the Chamber.

President Hope acknowledged each of the Directors on the Board for 2013/2014 year – Patrick Sager, Janis Entem, Dawn Rigby, Kathy Gilmour, Lisa Lockhart and Chris Hopkyns for their time and commitment to the Chamber and its Members. He stressed the countless volunteer hours that are willingly provided to assist will all the Chamber activities and voiced his appreciation to all of the Board of Directors.



## TREASURER FINANCIAL REPORT FOR 2014

D. Rigby presented the Treasurer's Report, beginning with a thank you to the Audit Committee. Timing in the invoicing and receipt of contract funds for the Visitor Centre, resulted in a net deficit for the year. The last contract disbursement for the season coming after our Fiscal Year End. As a result there will not be an addition to reserves this year, but we have not required any depletion of reserves, either. She noted that the revenue from the new Visitor's Guide may seem low but that is net revenue to the Chamber, as the layout, design and printing of the Guide was outsourced.

Treasurer Rigby requested a motion to accept the Financial Statements as presented.

Lowry Toombs motioned the approval and acceptance of the 2014 Financial Statements which was seconded by Rick Breakenridge. CARRIED

### TREASURER OVERVIEW OF 2014/2015 BUDGET FINANCIAL REPORT

D. Rigby presented the Budget forecast Financial Report for 2015, stating that adjustments to sponsored events have been made in order to improve the events to each be revenue neutral or show a net revenue benefit.
